Sub: Issue of Essentiality Certificate under rule 44 of Delhi School Education Act, 1973.


Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school from class Ist to VIIIth (without aid) in Distt. West subject to the following terms and conditions :- [Vill. Baprola PO Najafgarh, N.D. in

1. That the provisions of DSEA/R, 1973 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions laid down under rule 50 and will provide all the facilities given in rule 51 of DSER, 1973 to the Institution.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through cross cheques.
5. That the management of the school will not ask for grant in aid from the department.
6. That the school will not run for the profit of any individual, association or group of persons.
7. That in case at any time the management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name of Director of Education.
8. That all the recognised classes shall be run at the place only and no unrecognised classes will be run in the premises of the recognised school.
9. That the management of the school will apply for grant of recognition of the school under DSEA/R, 1973 and recognition will not be granted unless statutory/provisions of section 4(i) to (f) read with rules 50 & 51 are fulfilled.
10. That the school shall be run under the control of Sant Hari Dass Educational Society, Vill. Baprola, PO Najafgarh, N.D. and suitable funds will be made available. All the construction of suitable building on the land allotted to the society, as declared as per the specification of the department within a period of three year.

11. That the management of the school will obtain land from DDA in the name of the society through Directorate of Education, Delhi and shall construct a school building thereon for the proposed school as per specifications of the department.
12. That the adequate and sufficient Accommodation of 12 sq.ft. per student shall be provided for class room. The normal size of class-room will be 24'x20'. No other activities other than education shall be run.
13. If the recognition for the proposed school is not sought after fulfilling all the above conditions within a period of three years, this permission to run a new school shall be treated as cancelled.


